## Oak Tree 2022 Parking Permit Application

Archon Protection's **parking permit system** has been designed to enhance community security and expedite notifications in cases of emergency. Permits will be issued only to Oak Tree residents under the following circumstances:

1. You must submit a copy of **each** vehicle's registrations that are listed below.
2. There is a minimum of 3 (three) registered vehicles to the applicant's Oak Tree household (Four vehicles if the home has an approved driveway). \*
3. Each of the vehicles are currently registered with the CA DMV to the applicant's Oak Tree address.
4. The resident pays \$30 fee to Archon Protection per vehicle requesting a parking permit.
5. **The resident's garage MUST HAVE two of the three registered vehicles (the two non-permitted vehicles) PARKED INSIDE the garage at the time of the garage inspection and the vehicles receiving permits be present or else a permit will NOT be issued.**

### Limitations:

- a. The 1<sup>st</sup> parking permit will be specifically for Inner Parking Spaces and any additional permits will be for Outer Parking Spaces.
- b. Parking Permits may NOT be transferred to any other vehicles than the one they are issued to.
- c. Parking variances automatically expire on December 31st of the year they are issued.
- d. Parking Permits will not be issued to accommodate storage of non-operating or non-registered vehicles.
- e. Parking Permits will only be placed by an Archon Protection representative.
